Law No. 2014-01
SECHELT INDIAN BAND LAND TITLE REGISTRATION LAW

The Council of the Sechelt Indian Band, in open meeting assembled, enacts as follows:

1. This law may be cited as "Sechelt Indian Band Land Title Registration Law No.2014-01".

AUTHORIZATION

2. (1) The Band Council is authorized to apply under the *Land Title Act* for the registration of an indefeasible title to the land described in the Schedule to this law.

(2) For the purposes of the *Land Title Act*, the signature of a member of the Band Council or of another individual specified on the application form as an authorized signatory for the Band constitutes sufficient authority for the registrar to receive and act on the application.

NOTICE OF THIS LAW

3. On the making of this law,
 - a) notice of the date it was made and of the date it takes effect,
 - b) a copy of the law,
 - c) a copy of the survey plan referred to in the Schedule to this law, and
 - d) a copy of the documents by which the Band intends to apply for registration of an indefeasible title,


shall be forwarded to the Minister of Aboriginal Affairs and Northern Development Canada or a person designated by the Minister for the purpose of receiving such notices.
