Temporary Road Closure

Xenichen Ave between Swiyk'als Drive and Wharf Lane will be temporarily closed beginning Thursday, Nov. 3, 2016. The closure will be temporary in nature to allow the Nation's administrative staff, our community members, commercial tenants and local emergency services to assess the impacts of a more permanent closure.

RE: Trustee Electoral Area Variance

The Board of Education of School District No. 46 (Sunshine Coast) is undertaking a review of their Trustee Electoral Areas (TEA). Early this year, the Ministry of Education confirmed that certain Sechelt Nation band lands have been omitted from their metes and bounds descriptions of the district's TEAs in their ministerial order. The ministry has acknowledged the error and is requesting the Board's cooperation in updating the electoral areas for the school district.

While the ministerial order defining the district's electoral areas does not reference SIGD lands directly, the board has previously included SIGD lands with the description for Rural Area 2 in its local Trustee Elections Bylaw.

The current bylaw TEAs for School District No. 46 are defined as follows:

Gibsons	Town of Gibsons	One
Sechelt	District of Sechelt	Two
Rural Area 1	Sunshine Coast Regional District (Comprised of Electoral Area "A" – Egmont/Pender Harbour and Area "B" Halfmoon Bay in the Sunshine Coast Regional District)	One
Rural Area 2	Sunshine Coast Regional District (Comprised of Electoral Areas "D" Roberts Creek, "E" Elphinstone, "F" West Howe Sound in the Sunshine Coast Regional District and the "SIGD" Sechelt Indian Government District)

The specific boundaries of these areas are defined further by metes and bounds descriptions from the British Columbia Gazette (see the TRUSTEE ELECTIONS BYLAW NO. 74 for additional information).

The board has agreed to undertake a public consultation process in the fall and winter to gather input on any proposed variation to the current electoral areas. I have been directed by the board to solicit feedback from local governments prior to initiating the public consultation process, for the board's consideration in determining options for variations to the TEAs.

To provide some additional context, the board has discussed the following options:

- (a) Listing SIGD regions within the geographic TEA that borders each individual band land and redistributing the number of trustees elected by area, if necessary.
- (b) Including all SIGD lands in the Sechelt TEA and redistributing the number of trustees elected by area, if necessary.
- (c) Identifying SIGD lands as a single TEA with an elected trustee and redistributing the number of trustees in other TEAs.
- (d) Including all SIGD lands in TEA #4 (Rural Area 2) regardless of their geographic location

(status quo).

The board welcomes your input on this matter. I kindly ask that any preliminary feedback be provided by November 10, 2016 so that it may be included in the public consultation sessions.

Please note that additional opportunities for input will be available to all local governments during the public consultation phase as well.

TRUSTEE ELECTIONS BYLAW NO. 74 BOARD OF EDUCATION OF SCHOOL DISTRICT NO. 46 (SUNSHINE COAST)

A bylaw to provide for the determination of various procedures for the conduct of general school elections and other trustee elections.

Preamble:

Under the *School Act*, the board of education may, by bylaw, determine various procedures and requirements to be applied in the conduct of trustee elections. This bylaw applies to both general elections and by-elections, except as otherwise indicated.

In School District No. 46 (Sunshine Coast), trustee elections are held in the following trustee electoral areas:

TEA	Trustee Electoral Area Description:	# of trustees
Gibsons	Town of Gibsons	One
Sechelt	District of Sechelt	Two
Rural Area 1	Sunshine Coast Regional District (Comprised of Electoral Area "A" - Egmont/Pender Harbour and Area "B" Halfmoon Bay in the Sunshine Coast Regional District)	One
Rural Area 2	Sunshine Coast Regional District (Comprised of Electoral Areas "D" Roberts Creek, "E" Elphinstone, "F" West Howe Sound in the Sunshine Coast Regional District and the "SIGD" Sechelt Indian Government District)	Three

The board of education wishes to establish various procedures and requirements under the authority of the School Act for trustee elections.

The board of school trustees, in an open meeting of the board, enacts as follows:

1. Definitions

"Gibsons" refers to the Town of Gibsons as defined in the British Columbia Gazette dated November 30, 1995.

"Sechelt" refers to the District of Sechelt as defined in the British Columbia Gazette dated July 10, 1986.

"Rural Area 1" refers to Electoral Areas A and B of Sunshine Coast Regional District as defined in the British Columbia Gazette dated January 24, 1991.

"Rural Area 2" refers to Electoral Areas D, E and F of Sunshine Coast Regional District as defined in the British Columbia Gazette dated January 24, 1991 and the Sechelt Indian Government District.

ATTACHMENT #3

The terms used shall have the meanings assigned by the *School Act*, the *Local Government Act* and the *Local Elections Campaign Financing Act*, except as the context indicates otherwise.

"Board" or "school board" means the Board of School Trustees of School District No. 46 (Sunshine Coast).

"By-election" means a trustee election to fill a vacancy on the school board.

"Election" means a trustee election.

"General Voting Day" means the date on which general voting for a trustee election is to take place, whether part of the general school elections or a by-election.

"Minister" means the Minister of Education.

2. Required Advance Voting Opportunities

Unless the Board is exempted from the requirement by Order of the Minister of Education, an advance voting opportunity will be held on the tenth day before general voting day.

Unless the Board is exempted from the requirement for a second advance voting opportunity by Order of the Minister of Education, a second advance voting opportunity will be held on:

- (i) the date specified for the second required advance voting opportunity in an applicable municipal bylaw or a local government bylaw that is adopted by the board in this bylaw to apply to the trustee election; or as specified in the respective municipal bylaw if different.
 - (ii) if there is no such date, then on 3 days before general voting day.
- 3. Order of Names on the Ballot

The order of names of candidates on the ballot will be alphabetical.

4. Resolution of Tie Vote after Judicial Recount

In the event of a tie vote after a judicial recount, the tie vote will be resolved by lot in accordance with the *Local Government Act*.

5. Nomination Deposit

No nomination deposit is required for nomination for the office of school trustee.

6. Number of Nominators

For certainty, the minimum numbers of qualified nominators for a trustee candidate in Gibsons or Sechelt is two. The minimum number of qualified nominators for a trustee candidate in Rural Area 1 or Rural Area 2 is two.

7. Application of Local Government Bylaws

(a) In Gibsons, the election bylaws of the Town of Gibsons apply to trustee elections conducted by the Town of Gibsons, except for bylaws determining the minimum number of nominators, the order of names on the ballot, the resolution

of tie votes after judicial recount, requiring a nomination deposit, or any other matter on which the local government bylaws may not by law apply to a trustee election.

- (b) In Sechelt, the election bylaws of the District of Sechelt apply to trustee elections conducted by the District of Sechelt, except for bylaws determining the minimum number of nominators, the order of names on the ballot, the resolution of tie votes after judicial recount, requiring a nomination deposit, or any other matter on which the local government bylaws may not by law apply to a trustee election.
- (c) In Rural Areas 1 and 2, for a trustee election held at the same time as the general local elections, the elections bylaws of the Sunshine Coast Regional District, as they may be amended from time to time, apply to that trustee election, except for any bylaws determining the minimum number of nominators, the order of names on the ballot, the resolution of tie votes after judicial recount, requiring a nomination deposit, or any other matter on which the local government bylaws may not by law apply to a trustee election.

8. Elections Conducted by School Board

The following additional provisions apply to those trustee elections that the school board conducts on its own behalf except where the board has adopted a local government bylaw to apply to the trustee election.

(a) Additional Advance Voting Opportunities

The chief election officer is authorized to establish additional advance voting opportunities for each election and to designate the voting places, establish the date and the voting hours for these voting opportunities.

(b) Additional General Voting Opportunities

The chief election officer is authorized to establish additional general voting opportunities for general voting day for each election and to designate the voting places and voting hours, within the limits set out in the Local Government Act, for such voting opportunities.

9. Title

This bylaw may be cited as 'School District No. 46 (Sunshine Coast) Trustee Elections Bylaw No. 74."

10. Repeal

School District No. 46 (Sunshine Coast) Trustee Elections Bylaw No. 8600 is hereby repealed.

resulted in a small and very short lived relief from potholes.

Understandably, during the rainy season Stustus is mostly washboard

and full of potholes. The problem becomes exaggerated however due

to the recurring problem of a grader that seems never to be in Powell

River!

Capital Projects and Services for SBL #23 for 2017

Road Maintenance

Capilano Highway Services - contracted to grade, dust control and side trim.

Potholes remain a persistent issue.

Recommendation:

Asphalt or chip coat on Stustus Road or an increased contract for grading by Capilano Highway Services.

Quote received from Tyler Lambert, Area Manager of Capilano Highway Services for aggregate seal coat 570+ meters would be \$130,000

At the East end of Stustus Road (11441) is Lot 31-4, Nadja Hocking's property. The road ends at the top of a small incline and has never been maintained by Capilano even though it is Stustus Road. On the ocean side of the road there is a drop off that could be dangerous if any vehicle should drive too close to that edge.

Recommendation:

That it be levelled and packed and that a cement abutment or some solid logs be placed (on the ocean side) to prevent accidents. i.e. somebody driving off the edge. See photographs attached.

Trees:

In the past 3 months several residents have had trees broken by wind on their property. Also, one alder fell from the North side of Stustus, causing only a mess and no major damage.


On Nov. 21. 2015, trees on the North side of Stustus (SIB Land), broken in wind storms and/or old cracked trees that posed a hazard to traffic on

Recommendation:
The bulletin board needs to be removed completely. It is an eyesore and makes our area look rundown and uninhabited.
