LAW NO. 1989-05

A LAW TO PROVIDE FOR THE LICENSING OF BUSINESSES
IN THE SECHELT INDIAN GOVERNMENT DISTRICT

The District Council of the Sechelt Indian Government District, in open meeting assembled, enacts as follows:

1. This law may be cited for all purposes as the "BUSINESS LICENCES LAW".
2. For the purpose of this law, unless the context requires otherwise:

"Business" means carrying on a commercial or industrial undertaking of any kind or nature or the providing of professional, personal, or other services for the purpose of gain or profit.

"Resident Business" means a Business carried on, in, or from premises within the District.

"Non-Resident Business" means a Business, other than a Resident Business, carried on in the District, or with respect to which any work or service is performed in the District.

"District" means the Sechelt Indian Government District.

"Contractor" means any Person who does work in any field of construction, repair or remodelling under the terms and conditions of an agreement, verbal or otherwise, whereby a set sum or a sum calculated on a cost plus or unit basis is paid for the work done.

"Licence Inspector" means the Person from time to time duly appointed as licence Inspector for the District, and also any Person lawfully acting in that capacity.

"Person," where the context so requires, means any individual, firm or corporation, whether acting by themselves or by an agent, servant or employee, and shall include a body politic or corporate. The singular shall include the plural.

3. (a) No Person shall carry on any Business within the District unless:
 - (i) he or she has first paid for the Business the fee prescribed in Schedule "A" attached to and forming part of this law; and
 - (ii) he or she is the holder of a valid and subsisting Business licence issued to him or her by the Licence Inspector under the provisions of this law.
- (b) Every Person carrying on a Business within the District shall apply for a renewal of his or her Business licence prior to the commencement of each succeeding licence period and shall pay the prescribed fee for the Business licence at the time of application.
- (c) Every Person making application for a Business licence for the first time shall pay the prescribed fee for the Business licence at the time of application.
4. (a) Initial application for a Business licence shall be in a form as prescribed by the Licence Inspector, and shall be signed by the owner of the Business or his or her duly authorized agent, provided that, in the case of a partnership or joint ownership, any one of the owners or partners may apply and such application shall be deemed to be application by all of the owners or partners.
- (b) The application form shall be delivered to the Licence Inspector and shall be accompanied by the fee prescribed in Schedule "A".
- (c) Where the applicant for licences is one and the same Person, as many applications of the same kind as may conveniently be made on the form prescribed may be combined on one such form.
5. All fees collected by the Licence Inspector under this law shall be paid forthwith to the Treasurer of the District.
6. The Licence Inspector shall have the power to grant, issue, transfer or suspend Business licences as hereinafter provided.
7. (a) Except as hereinafter provided, licences shall be granted for a one year period, to commence on the first day of January and to terminate on the thirty-first day of December in each and every year. The licence fee prescribed in this law shall be reduced by one half in respect of a Person who becomes liable to be licenced after the thirty-first day of July in any year. No licence fee paid hereunder shall be refundable.
- (b) The period for a licence for a theatre, including a drive-in theatre, concert hall, opera house, rink, amusement

park or other place of amusement, entertainment or exhibition, shall be six months, three months, one month or one day, and the request for a particular period shall be by written application.

- (c) The period for a licence for a circus, horse show, dog show, pony show, exhibition or other itinerant show or entertainment, when held elsewhere than in a licenced theatre or other licenced place, shall be for one day.
 - (d) The period for a licence for horse racing shall be one day.
8. (a) Any licence granted pursuant to this law shall be deemed to be granted to the licensee named therein, and, if the operator of a Business changes, the new operator of the Business shall apply for a new licence pursuant to the terms of this law.
- (b) No Person shall carry on Business at more than one premise under one licence.
- (c) No Person shall change his or her place of Business without first obtaining a transfer of his or her licence in respect thereto, and the particulars of such transfer shall be endorsed on the licence by the Licence Inspector.
9. Any Person making application for a new licence to carry on a Non-Resident Business of any of the following classes of Business, namely:
- Auctioneer
 - Automobile Dealer
 - Direct or Door to Door Sales
 - Healer
 - Itinerant Seller
 - Pawn Broker
 - Scavenger

shall give as security to the District the amount of \$1,000.00. Such security shall be taken in the name of the District and shall be deposited with the Licence Inspector, together with the application for a licence and the prescribed fee.

10. The Licence Inspector or any peace officer or medical health officer is hereby authorized to enter at any reasonable time or times any premise, place or vehicle in respect of which a licence has been granted pursuant to the provisions of this law to ascertain whether provisions of this law are being observed.
11. Every Person who offends against any of the provisions of this law, or who does, suffers to be done, or permits any act or

thing which contravenes or violates any of the provisions of this law, or neglects to do or refrains from doing anything required to be done by this law, is guilty of an offence under this law and is liable on summary conviction to a fine or penalty of not less than \$25.00 and not more than \$500.00.



MULTIPLE
BUSINESSES

Every Person who carries on two or more classes of Business from one premise shall pay a licence fee based as follows:

- (i) the full licence fee on the principal Business being carried on, which shall be deemed to be that Business attracting the highest licence fee; and
- (ii) one-half (1/2) of the regular licence fee for each of the other class or classes of Businesses being carried on.

In no event shall the total licence fee be greater than twice the licence for the principal Business.

BYLAW NO. 2017-11

**A Bylaw to amend multiple laws
Regarding Titles**

WHEREAS most Sechelt Indian Government District (SIGD or the "District") legislation is titled "Law" rather than "Bylaw";

AND WHEREAS the SIGD wishes to harmonize its legislation to reflect its municipal nature;

NOW THEREFORE the District Council of the SIGD, in open meeting assembled, enact the amendments to the legislation listed in the Schedule to this Act as follows:

1. The title of the legislation be changed from "Law No." to "Bylaw No." For clarity, the numbers of each piece of legislation shall remain the same; and
