# ADVISORY COUNCIL REPORT NOVEMBER 16, 2018 SBL #23 COQUENEETS

Stustus Road is holding up nicely. Problem corner remains a problem. Washboard.

Ditches could still be cleaned to allow for better water run off, and prevent water running up and over the road and onto lessees properties. All's well at present but not sure what November storms will bring.

A "Palm Beach Regional Beach" sign has been installed right in front of the entrance to the park. In heavier summer traffic, this should prevent lost souls from venturing down Stustus Road.

Brookfield Power held a meeting on November 8th at the Lang Bay Community Hall. Re: Dam Safety and Inundation Mapping

The panel included Brookfield-Lois Dam, provincial, and BC Hydro experts regarding dam safety and inundation mapping. They reinforced the durability and safety of the dam but also mapped the affect in the rare event of a total dam failure. Our beach front lessees would have 14 minutes to evacuate in a worst case scenario, total dam failure. However, these findings were based on inundation studies assuming a hypothetical catastrophic failure. An independent review in 2017 and BC Regulations both concluded that Brookfield Dam is in excellent shape, receiving a clean bill of health and that arch dams are very robust during earthquakes. They have a Dam Safety Program that operates 24/7. We have all been urged to register with qathat Regional District's Emergency Notification System and to have a personal evacuation plan. I have already informed all the lessees.
