KEY THEMES FROM ENGAGEMENT

Affordability

Increasing unaffordability of housing for Members both on and off Nation Land was highlighted as a major concern throughout the survey and interviews.

Transparency

The survey highlights that while people generally appear to be aware of the housing waitlist it is felt that prioritization of Members on the waitlist are done in order of the date an application is received and not prioritized by need.

Cultural Support

Survey results suggest a desire for cultural and language supports to be integrated throughout a model for supportive housing.

Flexibility

Survey and interview responses suggest a need to 'decolonize' the process for obtaining stable housing, suggesting that supports are difficult to obtain for children that live with non-Members.

Wraparound Services

While many survey respondents suggested that they already have access to the supports they require to maintain the housing they need, others suggest wraparound support services are desired. Key services include mental health supports, addiction recovery treatment, cultural and language programs, recreational services, life skills training, and social gathering spaces.

Safety

Access to a safe and secure home was a very important theme throughout the survey and interviews with the need for long-term housing for victims of domestic violence being a common concern.

Education and Awareness

Survey and interview responses largely suggest that there is a need for increased education and awareness around the housing supports available to them.

Intergenerational Living

Many survey respondents suggest the need to think about how housing can be culturally appropriate and conscious of the importance of intergenerational living and shared learning for shíshálh.

Equity

The survey suggests a perception of unequal treatment for all Members (on Nation Land Members have easier access to housing). Interviews also shared the theme of the importance of equity, with interviewees noting that housing is mostly obtained through 'word of mouth' rather than through the Nation. This method of obtaining housing could but vulnerable Members at a disadvantage if it is about 'who you know' rather than who is most in need.

Inclusion

A distinct group of Members was not identified as a key 'priority group' through this engagement process. Rather, results suggest supportive housing should consider an inclusive approach to housing that aims to provide everyone access to safe and stable housing.

Long-Term Solutions

Engagement results highlighted the importance of considering long-term solutions rather than a traditional 'transitional housing' approach. Interviews in particular identified that the traditional method of supportive housing is often inflexible and unforgiving, with the often short timeframes and strict regulatory processes making it difficult for vulnerable people to maintain a sense of stability and security.

Building Capacity

Engagement results highlight a shared desire between the Nation and Members to not only provide supportive housing programming but also to set Members up to help and support each other as a community.

Supportive Housing Needs

Survey results suggest there was no one type of housing that is rated much higher in urgency than others. Assisted Living for Elders (with 24/7 support) was rated slightly higher than others at 47.7%, however, four other types of housing were also rated between 46.6% and 42.1% in importance. This suggests that supportive housing should take a more comprehensive approach, integrating supports to meet the needs of a variety of different people.

Compassion

Engagement results suggest the need for compassion and understanding when creating about supportive housing policy rather than creating strict regulatory processes.

KEY THEMES RELATED TO FAMILIES

Specific Needs & Life Skills Development

Survey results indicate that housing for families is currently lacking especially for those with any special needs. Themes also suggest it is important to consider the needs of young families just starting out and single parents in need of support. The survey and interviews indicate a need for support with life skills development like cleaning and parenting.

Non-Conventional Families

22% of shishalh members that have dependents indicated that one or more were not considered relatives by blood, marriage, or adoption. Results also pointed out that some shishalh children live with non-members that are not supported under the current housing application. shishalh could consider a more non-traditional approach to how families are defined and perhaps revisit the criteria for providing housing to ensure member children living with non-members are supported, as well as ways to support members that are taking in non-relatives in need of housing.


Affordability and lack of housing supply

While not specifically related to supportive housing, perhaps the biggest themes in the survey and interview results was overall unaffordability of housing and lack of housing supply. Results suggest that there are more affordable options needed that are appropriate for families.

Intergenerational living

This was not a theme that was directly mentioned outside of the workshop but many respondents in the survey (and some in interviews) did mention that overcrowding is a key issue for shíshálh. Some alluded to the connection that providing enough housing for Elders (i.e., housing Elders appropriately if they are looking to downsize), could help to free up some of the larger homes for families that require more space.



Q2 Which of the following most closely describes where you currently live: (If outside of shíshálh swiya, please specify where).










Q5 Are you currently on the shíshálh Nation housing waitlist?







Q11 What kinds of supports do you and your household need? (Select all that apply)



Q12 Do you feel that your household has access to all of the housing supports that you need? If no, why?





Sche'Lang'En Village

A gated community with 45 new units of housing for elders and families with high needs. 9 single-story 2-bedroom duplexes for elders, 24 two-story 3-bedroom units in pods of four; and 12 single-story 3- and 4-bedroom triplexes. Community club house, private counseling offices, community garden, playgrounds and picnic areas.






Native Counselling Services of Alberta (NCSA) Housing First Program:

- Assisting with setting up apartment (furniture, household items, groceries)





