

NOTICE OF ELECTION

An Election for one (1) Chief and four (4) Councillors will be held pursuant to the shíshálh Nation Constitution and the provisions of the shíshálh Nation Election and Referendum Law dated April 15, 2019. Individuals who are on the shíshálh Nation voters list, and who are at least 18 years of age, by February 18, 2023 are entitled to vote for one (1) Chief and four (4) Councillors.

Voters may attend the Nomination Meeting on January 4, 2023 to nominate candidates for the election.

Time: 2 p.m. to 6 p.m.

Election Day: **February 18, 2023**
Location: shíshálh Nation Community Hall
Time: 9 a.m. to 8 p.m.

The Voters' List will be posted in the shíshálh Nation's Administration Building and on shíshálh Nation's website on or before December 20, 2022.

If your name is not on, or appears incorrectly on, the Voters' List you must, by no later than January 9, 2023, make an application to the Electoral Officer setting out the reasons why your name should be added to, or changed, on the Voters' List and any documents supporting your application.

If you believe a person listed on the Voters' List should not be included on the Voters' List you must, by no later than January 19, 2023, make an application to the Electoral Officer setting out the reasons why the person's name should be removed from the Voters' List and any documents supporting your application.

Voters who are ordinarily resident on Sechelt Lands and unable to vote in person due to disability on the date of the election, or voters who are not ordinarily resident on Sechelt Lands, may vote by mail-in ballot if they deliver a completed Application for Remote Ballot to the Electoral Officer by no later than **January 19, 2023**. The application form can be obtained from the Electoral Officer.

Copies of the Sechelt Indian Band Constitution and shíshálh Nation Election and Referendum Law can be obtained at the shíshálh Nation's Administration Building and electronically on shíshálh Nation's website.
